Open Letter
Amicus curiae

May it please Your Majesty,

It gives us pleasure to report that Banco General S.A. has proved itself capable of reading the legal document in English that follows and have re-enabled the account of Keison S.A., Panama operated by Lord Keir Argent, Duke of Switzerland in Your Majesty's Commonwealth.

This is a non exclusive list, Trust property also includes, but it is not limited to the property at 32 Writtle Road, Chelmsford, England, all tangible and intangible assets connected with the Keison brand, the stock at the warehouse and all stock that has been ordered and is in transit.

Of these, the Banco General, S.A. management, as we have noted, has proved capable of reading and writing and have ceased to obstruct Trust activity. We have heard testimony that the U.B.S. account manager Fabio Barmettler will not accept the faulty paperwork from the administrators of KEISON INTERNATIONAL LIMITED. This bodes well for him.

Paypal, has at the top of its 'structure' a Luxembourg 'bank'. It is our wish that **Grand Duke Henri of Luxembourg** alert them about the faults in their current process.

The response to this *Amicus curiae* of each 'bank', so called, which 'stores' "USEd Toilet Paper Tokens", to use an expression from the draft Your Majesty has seen, shall determine the fate of the Chairman, CEO, Board of Directors, shareholders and 'compliance' officers.

The same applies to *Companies House*, whose CEO is Tim Moss, who is backed up by Martin Donnelly, the Business Secretary and Jonathan Jones, Head of the Government Legal Service; and the board of directors of Nominet, which purports to provide customer service, all of whom have already acknowledged receipt of our *Misprision of Treason* document sent to Marston Holding, together with attachments.

Chief Constable Stephen Kavanagh and Chief Inspector Alan Cook, District Commander of Essex Police have also been informed, along with a number of other U.K. police HQs. Recent news, "A Royal Navy vessel ... was hosting an open day for police in the North East", shows that action has been taken to show the police that their weapons are no match for those of Your Majesty. Do they see that or are they like the simple, innocent "Indians" encountered by early western explorers who fell asleep on the ship they were taken to see?

16MAY16 - I called Peters & Peters, solicitor Jason Woodland, who I was connected to after explaining the nature of my enquiry:

I explained that there were 2 main aspects to the case:

1) A conflict on judgements for an administration order on Friday 06MAY16 which claimed to dismiss the 'winding up petition' and a 'winding up order' on Monday 09MAY16 which was dismissed 'again'.

2) Our claim of nullity ab-initio due to faulty processes and documents in the 'statutory claim'
