Regarding our past Amicus curiae(s) to assist Her Majesty The Queen with the dissolution of the Federal Reserve et al, we have requested that the House of Lords fax desk deliver copies to all Law Lords of the kingdom and have copies available at the Clerk of Parliament. The current dysfunctional Parliament and Government may not have delivered such copies. This failure to act, in itself, is obstruction of justice or even a treasonable offence.

It is our wish that you ask their Lordships if they have seen such copies. It is our wish that you assist them with printing those sent to the House of Lords as they are cumulative. In the High Treason investigation of the courts purporting to be managed by U.K. PLC, we wish to know if the noble Lords of Justice operate a 'collective' system of justice, whose fate is tied to the collective cabinet.

The urgent question the noble Lords must contemplate is, does the Chancery Division Chief Registrar Baister need guidance regarding the case scheduled for 09 May 2016.

The consequences of an incorrect decision could prove fatal to many. The traditional English remedy for High Treason is not a pleasant affair. It would be better to dissolve Parliament and shutter the courts of U.K. PLC.

The English Common Law courts operated by magistrates of the Queen's Bench, for example, can continue to provide the police constabulary with the legal power to arrest those that breach the Queen's Peace under the original Justices of the Peace Act 1361.
